Expanded Core Values Document for FPI's Rural and Urban Agriculture Innovative Production Program (RUAIPP)

1. Research and Development Excellence

Value Explanation:

- **Relevant:** Ensure that 70% of farmers in RUAIPP regions adopt at least one new farming technology by 2026.
- **Time-bound:** Implement 100% of new technologies within 2 years of successful pilot testing.

2. Traditional Skills and Knowledge Integration

Value Explanation:

- **Time-bound:** Establish at least 10 community partnerships with cultural leaders each year.

3. Rural Development and Urban & Peri-Urban Farming

SMART Objectives:

- **Measurable:** Support 20,000 farmers in both urban and rural areas through agricultural training by 2028.
- **Achievable:** Increase agricultural land use in peri-urban areas by 15% within 5 years.
- **Relevant:** Partner with 5 local governments to include urban farming programs in city policies by 2026.
- **Time-bound:** Achieve a 25% increase in local food production within urban areas by 2030.

4. Economic Empowerment

Value Explanation:

- **Time-bound:** Reach a gender balance in agricultural cooperatives by 2028.

7. Financial and Material Accountability

- **Achievable:** Ensure 90% of project budgets are spent effectively, with no discrepancies, by 2027.
- **Relevant:** Implement cost-efficiency measures to reduce operational costs by 15% by 2030.
- **Time-bound:** Publish an annual transparency report by the end of each fiscal year.
